TERMS & CONDITIONS

In consideration of the sale of the dog to the Buyer, Seller and Buyer agree to the following terms and conditions:

SELLER RESPONSIBILITIES

The Seller certifies that all pedigree and health information is true and correct to the best of their knowledge. The puppy will be wormed, first shots, vet checked, AKC registered and be microchipped for permanent identification. Seller agrees to give support and advice for the life of the dog.

BUYER RESPONSIBILITIES

The Buyer shall provide a loving home, high quality food and fresh water in clean containers, regular veterinary checkups, immunizations, annual deworming, medical treatment if necessary, and the emotional support required to maintain good health and happiness of this dog. The dog will be given sufficient training required to make a good family pet. This dog must be raised indoors as part of a family and be kept in good physical condition.

The Buyer will never let the dog run loose, roam, wander unattended, keep the dog chained or tied up, keep it continuously in a yard, garage, patio, balcony, or pen, or leave the dog outdoors, even in a fenced yard, when no one is at home. It shall not be allowed on areas that have been freshly treated with chemicals (weed killers, fertilizers), and all toxic chemicals shall be kept out of reach of the dog. It shall not be left in a vehicle during extreme and warm weather conditions. The Buyer will keep the dog away from public places until fully vaccinated, and during vet appointments will not allow the dog on the ground or floor of the premises until fully vaccinated, due to the possibility of contracting a contagious disease.

The Buyer agrees to notify the Seller of any change of address, phone number and/or email address, and provide the Seller with any changes in the event the Buyer moves or changes their contact information.

The Buyer agrees to contact the Seller immediately within 24 hours in the event of the dog's death or any emergency, serious event or concern where the dog's life, health or wellbeing is at risk. The Buyer agrees to communicate with the Seller if they are having any problems or concerns with the dog, to occasionally let the Seller know how the dog is doing, and allow the Seller to visit the dog if desired.

MICROCHIP

The Buyer agrees to enroll the puppy's microchip with AKC Reunite, listing the Buyer as Owner and Fields' Folly as Alternate Contact, and to keep their contact information up to date in the event of any changes. The Buyer understands if they do not enroll the puppy's microchip, Fields' Folly remains on file as the purchaser and primary contact of the puppy's microchip. In the event the puppy is lost and Seller is contacted, Seller will attempt to contact the Buyer with the information provided. The Buyer understands the AKC Reunite warning that anyone who finds a pet with an unenrolled microchip can enroll the pet in their name and claim the pet as their own. The Seller is not notified when a microchip has been enrolled and therefore claims no responsibility to whom is listed as Owner when and if the microchip is enrolled.

SPAY/NEUTER AGREEMENT

This puppy is being sold as a pet/companion only and will not be used for breeding and/or showing. The Buyer will have the dog spayed/neutered between 18-24 months of age and no less than 12 months of age, for the safety and proper development of the dog. The Buyer will provide a spay/neuter certificate and/or vet receipt of procedure to the Seller at that time. The buyer agrees that if they do not follow this agreement and use the dog for breeding purposes, the Seller has all rights to immediate repossession of this dog with no refund to the Buyer.

SURRENDER

If the dog is found to be allowed to run freely, running at large, creating a public nuisance, or found to be neglected, abused, improperly fed, denied medical treatment, left in a hot vehicle or allowed to live in poor health or poor conditions, or in any other situation the Seller deems as reasonably unsuitable for the dog to continue to live, the Seller has all rights to repossession of this dog with no refund to the Buyer. The Buyer will willingly surrender the dog and all rights to ownership at the demand of the Seller. At the time of surrender the Buyer will provide the Seller with the dog's AKC registration with Buyer's signature on the back of the form, allowing for ownership transfer of the dog, along with all other paperwork provided and associated with the dog. The death, injury, or loss of said dog due to theft, carelessness, recklessness, abuse, neglect, heat stroke or accident will not entitle the Buyer to any compensation from the Seller.

In the event the Buyer is unable to keep this dog for any reason (including but not limited to allergy, landlord/tenant issues, marital/relationship or adjustment problems, relocation, etc.) the Buyer agrees to return the dog to the Seller immediately. If the Buyer returns the dog for any reason it will be on a surrender basis only with no refund. At the time of return the Buyer will provide the Seller with the dog's AKC registration with Buyer's signature on the back of the form, allowing for ownership transfer of the dog, along with all other paperwork provided and associated with the dog. The Buyer will pay for all travel expenses for both Buyer and Seller related to the return of the dog. If the Buyer has a home in mind that they would like to re-home or re-sale the dog to, the Seller will take this into consideration. In such an event the Buyer must notify the Seller with the new name, address and contact information of the new Buyer, who must be interviewed and approved by the Seller first. The Buyer will not be compensated for any rehoming fee negotiated by the Seller. Buyer agrees not to sell or voluntarily relinquish this dog to any retail company, rescue organization or humane society.

GUARANTEE

The Seller guarantees the life of the puppy for 1 year, per the terms of the following conditions. Any common bulldog issues, illnesses or contracted contagious diseases are the responsibility of the Buyer to correct. If the puppy is found to have a life-threatening genetic disease from birth within the first year, a statement from a licensed veterinarian of Seller's approval confirming such an event and that the genetic disease was the sole and primary cause of death is required before any action will be taken by the Seller. The Seller reserves the right to request a second opinion by a veterinarian of the Seller's choosing to determine the genetic disease and the cause. The Buyer agrees to make arrangements for transportation of the puppy to the Seller's veterinarian of choice within a timely manner for proper examination and diagnosis. This health guarantee does not cover any veterinarian, medical or transportation costs. The Buyer is aware that owning a puppy means frequent visits to a veterinarian and understands that the Buyer will be responsible for all payments.

In the unlikely event of the death of the puppy within one year of date of birth due to such genetic disease, the Seller, at the Seller's choice, shall either refund the Buyer the purchase price of the puppy or replace the puppy with the next available puppy of equal value. If the Seller

offers a replacement puppy and Buyer declines the replacement puppy, then the Seller and Buyer shall be under no further obligation and it will be deemed that the Buyer has released the Seller from any and all further claims.

No guarantee is made as to the disposition, conformation, temperament, size, weight, color, or markings of the puppy. No guarantee is made as to the speed with which the puppy will house train or train in any other capacity. No guarantee is made for any other traits or behaviors that may develop as the puppy adjusts to its new home and grows up. The Buyer understands there may be an adjustment period when a puppy moves to a new home and agrees to provide the patience, love and opportunity necessary to ensure the puppy has a smooth transition and the time he needs to fully adjust. The buyer agrees to enroll the puppy in behavioral training class. In the event of any behavioral problems that may arise at any time of the life of the dog, the buyer agrees to enroll the dog in corrective/reactive behavioral training and will make every effort to train and correct any issues.

ACCEPTANCE OF HEALTH CERTIFICATE

Buyer accepts the provided Certificate of Health signed by Seller's veterinarian during the puppy's health check, including any findings and notes provided by the veterinarian of any health issues discovered. Seller will communicate those findings to the Buyer prior to transfer of the puppy so Buyer is aware and can plan accordingly. Any discovered health issues are the responsibility of the Buyer to treat and correct, unless otherwise arranged. Buyer agrees to provide all medical treatment necessary, including all associated financial costs.

MARKETING

The Buyer gives permission to the Seller to share future photos provided of dog for marketing purposes such as on social media, Seller's website, and to future Fields' Folly customers.

EXECUTION OF CONTRACT

By signing this contract, Buyer and Seller agree to acceptance of all terms within the contract. This contract is not binding and enforced until the pickup date in which possession of the dog has been transferred from the Seller to the Buyer.
